During the quarter pursuant to Composite Scheme of arrangement 2 promoter group companies viz. Decent Electronics Private Limited and Ekadant Investment Private Limited were amalgamated with and into Shri Rameshwara Investment Private Limited and Karad Engineering Consultancy Private Limited was amalgamated with and into Shri Badrinath Investment Private Ltd.
