**Subject: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015 (“LODR Regulations”).**

In continuation of our earlier disclosure dated 1<sup>st</sup> December 2023 it may be noted that vide an order dated 6<sup>th</sup> December 2023 that was uploaded on 12<sup>th</sup> December 2023, the Hon’ble Bombay High Court while hearing an interim application filed by Gujarat Pollution Control Board (in Writ Petition No. 1124 of 2023) for the vacation of the interim order passed by the Hon’ble Bombay High Court of 24<sup>th</sup> March 2023 staying the order of the NGT of the same day, has observed that *“The last date in the Farad sheet is 7 July 2023 which adjourns the Petition to 21 July 2023 and continues the ad-interim order till that date. Thereafter as per the record there is no further continuation of the interim relief. The Petitioner has not circulated the Petition thereafter”*. The Hon’ble Court on that basis has held that *“the prayer made in the application for vacating the stay does not arise”*.

The Company, in consultation with its legal advisors, proposes to seek appropriate legal remedies.
